FEES & REGISTRATION:

A once off joining fee of R500 is required on registration students pay R400. The joining fee for kids under 12 years is R250. A debit order payment system is mandatory for all clients, unless an upfront contract is taken.

CONTRACTS & PRICING STRUCTURE:

Membership fee is R980 per month for a minimum 12 month contract. The Student Rate is R880 for a minimum 12 month contract. The rate for kids under 12 is R500 per month. Membership allows unlimited access to the gym and to attend an unlimited amount of group classes.

Other fee structures include:

6 month upfront payment - **R6500**; 3 month upfront payment - **R4050**; One month - **R1800**

Private training :

Private training sessions start at R400 per hour. Terms & Conditions apply.

TERMS AND CONDITIONS:

1. Missed classes cannot be made up or carried over into another month. Contracts cannot be put on hold over holiday periods, Religious, student or otherwise. Debit order contracts will run consecutively for the minimum 12 month period.
2. A student discount is applicable only to those with a valid student card.
3. Contracts cannot be canceled within the 12 month contract period. After 12 months the contract will continue to run month to month until written notice is given. Cancellation requires 1 calendar month notice to cancel the contract after the contract period ends.
4. PFA does not accept responsibility for any personal injuries or damage or loss of personal property.
5. Everyone must have all their own training gear, including a large sweat towel at each session.
6. Filming happens occasionally for marketing purposes, should you not wish to be filmed or photographed please notify management on signing up.

ii. Monthly; on or after the dates when the obligation in terms of the Agreement is due and the amount of each individual payment instruction may not be more or less than the obligation due;

I / We understand that the withdrawals hereby authorised will be processed through a computerized system provided by the South African Banks and I also understand that details of each withdrawal will be printed on my bank statement. Each transaction will contain a number, which must be included in the said payment instruction and if provided to you should enable you to identify the Agreement.
